**Kings Consolidated School District #144
Resolution to Levy 2023 Taxes**

2023-01

WHEREAS, Article 17 of the Illinois School Code authorizes the Board of Education to levy special taxes for various school purposes; and

WHEREAS, The Truth in Taxation Act requires that all taxing districts in the State of Illinois determine the estimated amounts of taxes necessary to be levied for the year not less than twenty (20) days prior to the official adoption of the aggregate tax levy of the district; and

WHEREAS, if the estimated aggregate amount necessary to be levied, exclusive of the election costs, exceeds 105% of the aggregate amount of the property taxes extended or estimated to be extended upon the levy of the preceding year, public notice shall be given and a public hearing shall be held on the district's intent to adopt tax levy in an amount which is more than 105% of the extension or estimated extension for the preceding year; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of King's Consolidated School District No. 144, County of Ogle, State of Illinois, as follows:

Section 1: The aggregate amount of taxes estimated to be levied for the tax year 2023 is \$1,411,826.

Section 2: The aggregate amount of taxes estimated to be levied for the year exceeds 105% of the taxes extended by the district in the tax year 2022.

Section 3: That the Board President and Board Secretary are hereby authorized to execute the Certificate of Tax Levy and the District administration is hereby authorized and directed to file the Certificate of Tax Levy and all supporting data and Certifications with the County Clerk of Ogle, County, Illinois.

**Notice of Proposed Property Tax Increase for
Kings Community Consolidated School District #144**

- I. A public hearing to approve a proposed property tax levy increase for Kings Community Consolidated School District #144 for 2023 will be held on December 20, 2023 at 6:00 pm at Kings Elementary School, 100 1st St, Kings IL 61068

- II. The corporate and special purpose property taxes extended or abated for 2022 were \$1,301,186.

The proposed corporate and special purpose property taxes to be levied for 2023 are \$1,411,826. This represents a 8.50% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2022 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for 2023 are \$0.

- IV. The total property taxes extended or abated for 2022 were \$1,301,186.

The estimated total property taxes to be levied for 2023 are \$1,411,826. This represents a 10.44% increase over the previous year.

PUBLICATION REQUIREMENTS

The notice shall be no less than 1/8 page in size.

The type shall be at least 12 point.

The notice shall be enclosed in a black border no less than 1/4 inch wide.

The notice shall not be placed in that portion of the newspaper where legal notices and classified ads are published.

- V. The notice shall be published not more than 14 days and not less than 7 days prior to the hearing date.
